- Agree to involvement, as chair, of one of CPRS Calgary committees
- Term of Office: two years (with the exception of President-elect, which is a three-year term serving consecutively as President-elect, President and Past-President)

The Nominating Committee has determined that all nominations must be returned **by no later than Thursday, June 9, 2022.**

If there are more candidates than vacancies, the slate of the candidates will be distributed to all CPRS members in good standing by June 16, 2022 and will be voted on during the CPRS Calgary Annual General Meeting.

The 2022-2023 Board of Directors will be announced at the Annual General Meeting of CPRS Calgary, which will be held in person on June 23, 2022 beginning at 5:00 p.m. MDT.
